Gifts can be made today in many different ways. Pretty much anything of value can be gifted to the Fund. Here are some instructions for different types of gifts:

- **Gifts made by check** should be made payable to “CNYCF” or “CNY Community Foundation,” with a note on the check “for Eisenhower College Legacy Scholarship Fund.” These can be mailed to 431 E. Fayette St., Suite 100, Syracuse, NY 13202.
- **Gifts can be made by credit card** by going to www.cnycf.org/funds. Search for “Eisenhower,” and then click on “Donate Now” when the Eisenhower College Legacy Fund comes up. Standard credit card processing fees apply.
- **Gifts of stocks, bonds, and mutual funds** require transfer instructions from CNYCF. These instructions differ depending on the brokerage relationship used. Please contact Tom Griffith, VP of Development, at tgriffith@cnycf.org or 315-883-5544 for assistance.
- **Gifts of real estate, life insurance, commodities, collectibles, or really anything else**, please contact Tom Griffith, VP of Development, at tgriffith@cnycf.org or 315-883-5544 for assistance. (Note that CNYCF will not accept gifts of vehicles, boats, or livestock.)

- **Words for a will or trust:** *I give, devise, and bequeath to the Central New York Community Foundation (EIN 15-0626910), Syracuse, New York, a New York non-profit corporation, [%, \$ or other] to be held, administered and used by the board of directors for the Eisenhower College Legacy Scholarship Fund.*
- **Beneficiary Designation:** Our listing as beneficiary should be “Central New York Community Foundation Inc., EIN 15-0626910, 431 E. Fayette St., Suite 100, Syracuse, NY 13202,” and if space is provided, include “FBO Eisenhower College Legacy Scholarship Fund.” When making a beneficiary change, the donor should notify CNYCF of their intentions for the gift.

NOTE: Funds pledged to the Eisenhower College Legacy Scholarship Fund will only be used for their stated purpose and will not be used to pay operational expenses of the Eisenhower College Alumni Association.
